

Official Rules for 2018 Member Survey \$50 Gift Card (“Sweepstakes”)

NO PURCHASE NECESSARY. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING. SWEEPSTAKES OPEN ONLY TO EAGLE COMMUNITY CREDIT UNION MEMBERS. VOID WHERE PROHIBITED BY LAW.

1. How to Enter: The **2018 Member Survey \$50 Gift Card** (“Sweepstakes”) begins at 12:00 a.m. (PT) on February 12, 2018 and ends at 12:00 p.m. midnight (PT) on February 20, 2018 (“Promotional Period”). This Sweepstakes consists of 2 drawings of 2 \$50 Gift Cards, whichever is less. To enter the Sweepstakes during the promotional period, a member must complete our 2018 Member Survey and they will automatically receive one (1) Sweepstakes entry. **To enter by mail**, hand-print your complete name, address, city, state, zip, phone number (including area code) and the words “Gift of Membership Promotion Giveaway” on a 3"x 5" card, and mail in a stamped #10 envelope, hand printed, to: **“2018 Member Survey \$50 Gift Card** PO Box 5196, Lake Forest, CA 92609. Mail-in entries will be accepted beginning February 12, 2018. Entries for the last monthly drawing must be postmarked by February 20, 2018 and received by February 21, 2018. Enter as often as you wish; however, only one entry per stamped envelope will be accepted per day. No mechanical reproductions permitted. Entries become the sole property of the Sponsor and will not be acknowledged or returned.

2. Eligibility: Sweepstakes is open to members of Eagle Community Credit Union who receive our survey. Eagle Community Credit Union employees and volunteers, their immediate families and persons living in their households, whether related or not, are not eligible. Void where prohibited or restricted by law. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. In the event of conflicting law, the law of California will prevail.

3. Odds: The estimated odds of winning a prize for a weekly drawing depend on the total number of eligible surveys received for that time.

4. Prizes: Two winners will receive a \$50 Gift Card valued at \$50. No substitution or transfer of prizes permitted except that Sponsor, at its sole discretion reserves the right to substitute a prize for one of equal or greater value for any reason whatsoever. Winners are responsible for the payment of all federal, state, and local taxes on the prizes.

5. Drawing and Notification: Potential winners will be randomly selected in two drawings being held on or after February 20, 2018 from among all eligible entries received by Sponsor. Drawings that would occur on holidays will be conducted on or after the following business day. The deadline for entry in a monthly drawing is 6 p.m. (PT) Thursday prior to the drawing. Non-winning daily entries will be eligible for all subsequent drawings. Winners will be notified by email by the email previously provided by the member and/or by phone. Should the winner decline the prize, an alternate winner may be selected from the remaining eligible entries, at Sponsor's sole discretion. Winner's acceptance of a prize constitutes permission for the Sponsor to use winner's name and address (city and state only) information, for advertising/publicity purposes and in all forms of media (including posting on web site), in perpetuity, without further notice to or compensation in connection with said Sweepstakes or the prize awarded. If the winner is a minor, then a parent or guardian must sign the acceptance documentation to receive the prize.
